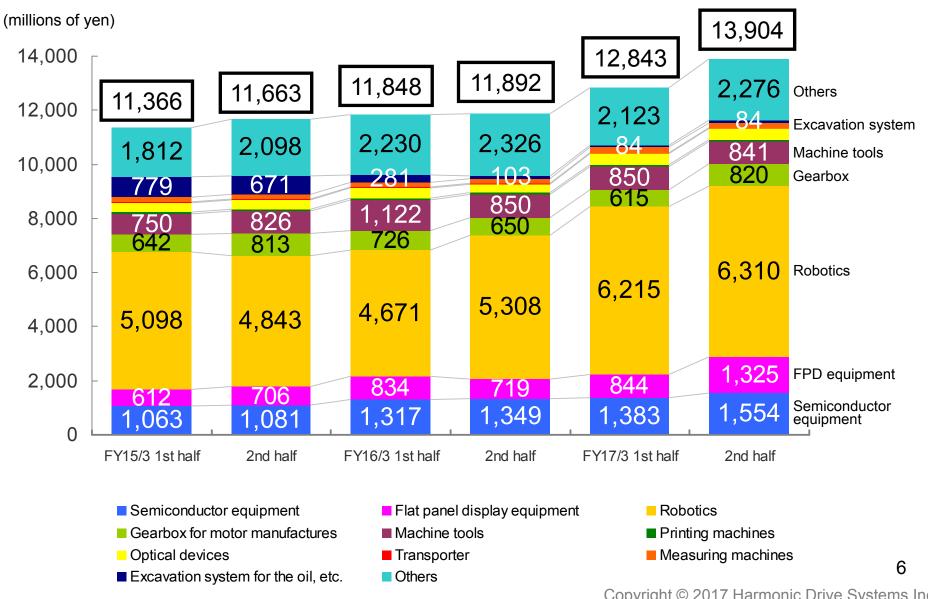

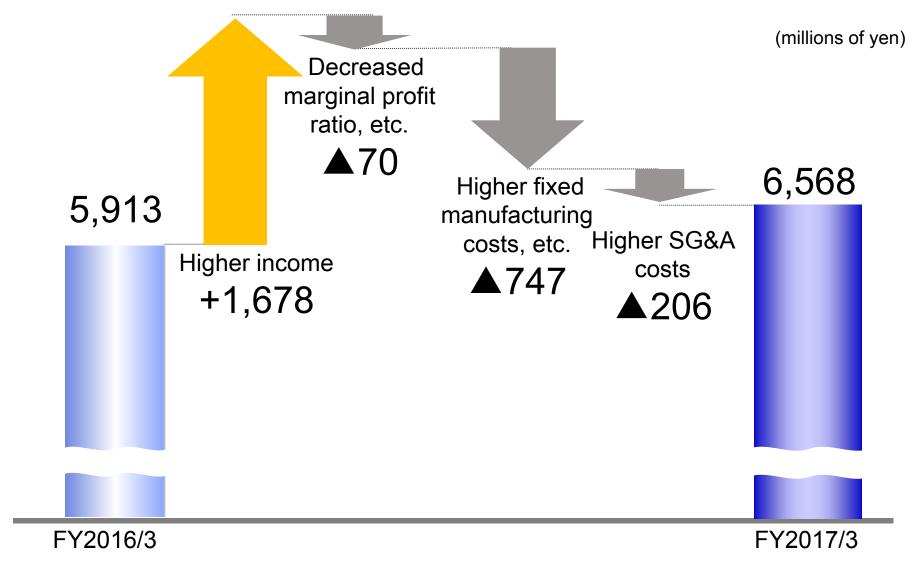

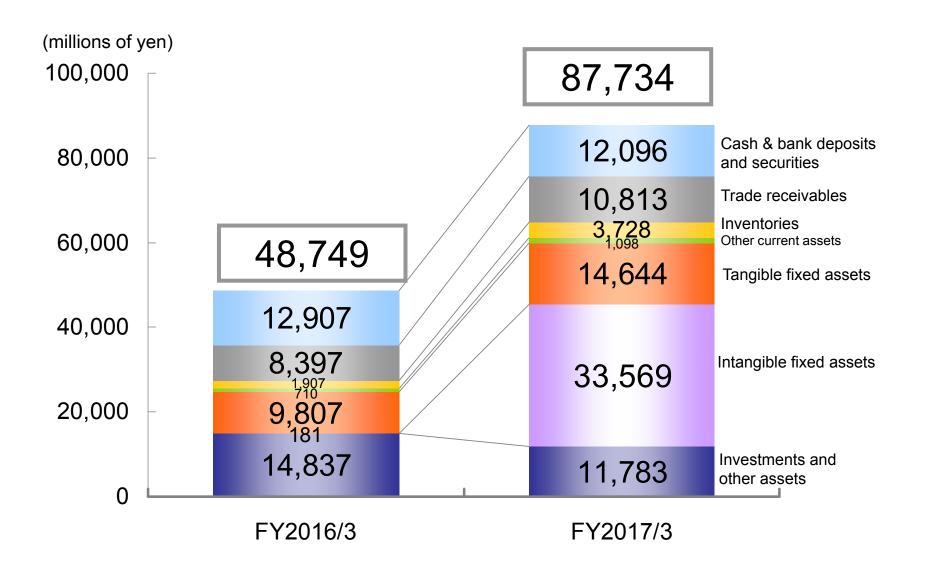
Net sales by application (non-consolidated)



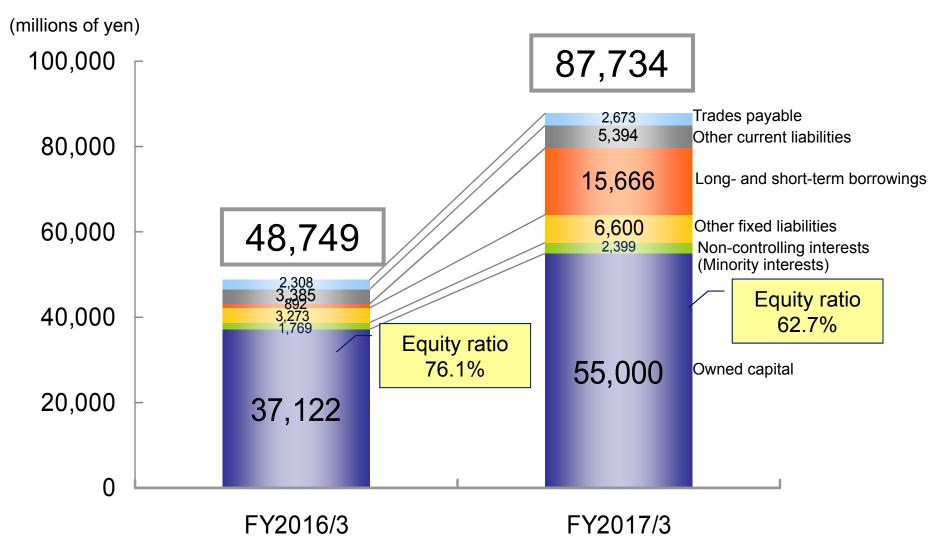
Factors in year-on-year change in non-consolidated operating income (FY2017/3)

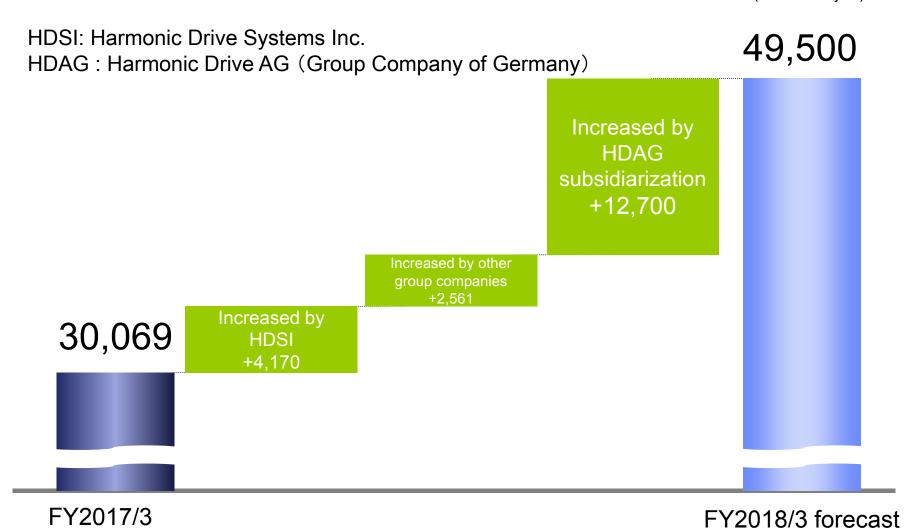

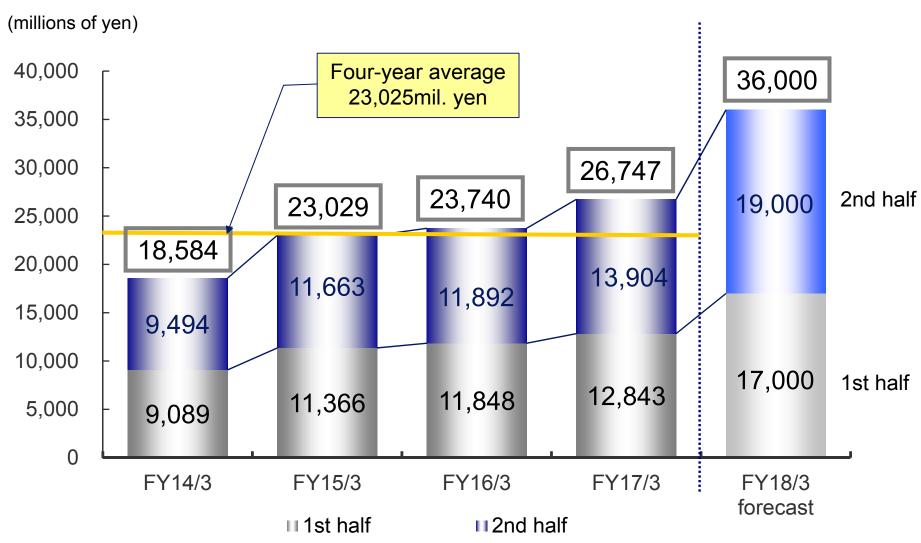

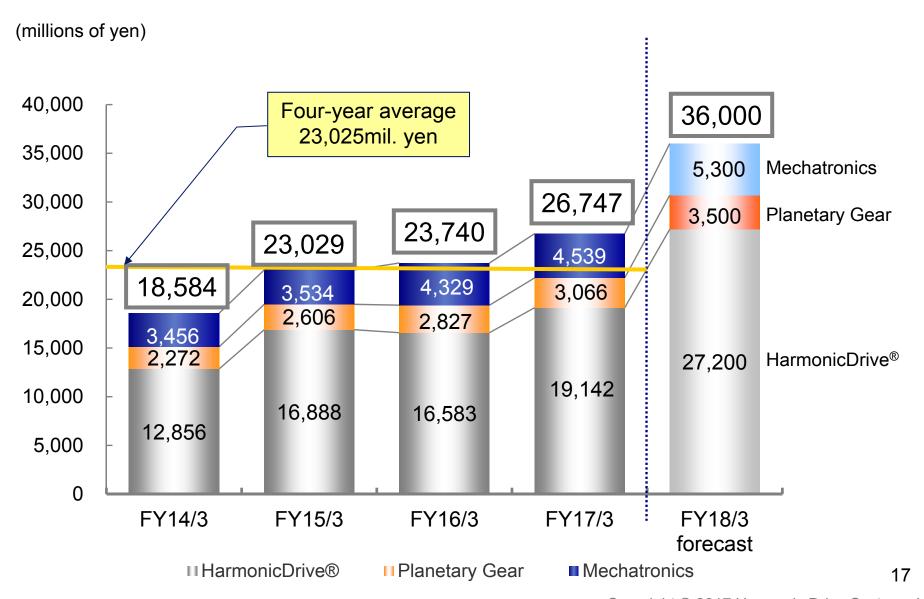

Sales trend line (non-consolidated)

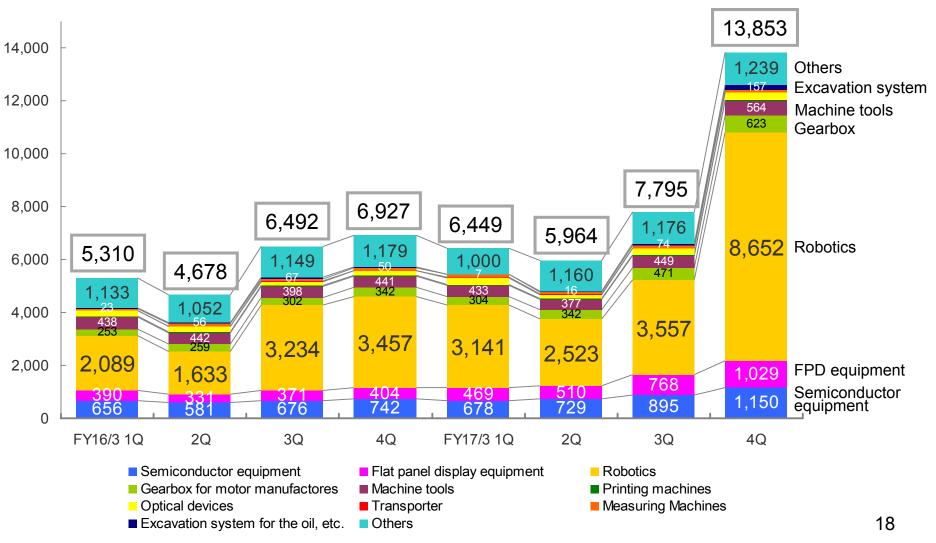


Sales trend line by product (non-consolidated)

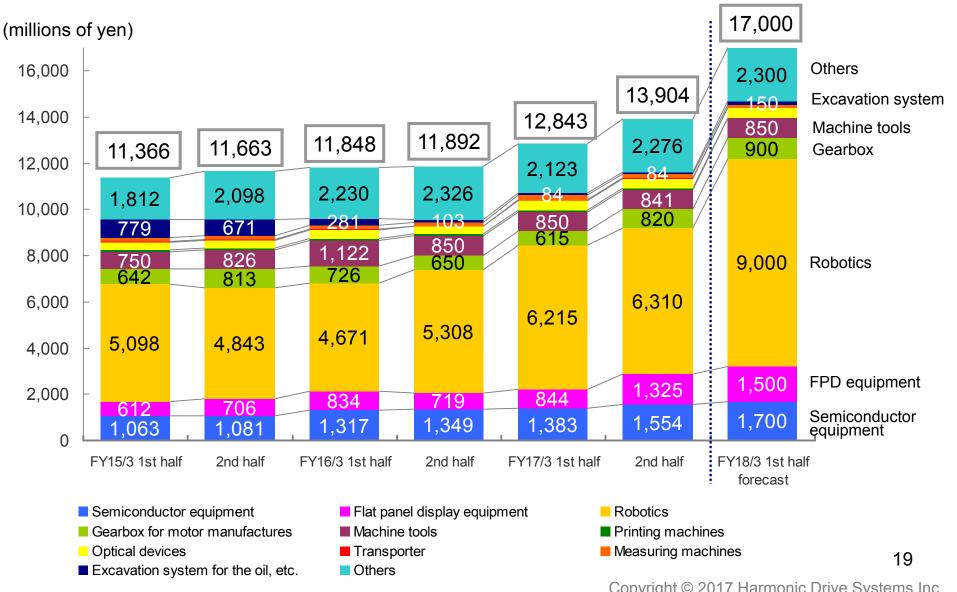


Non-consolidated bookings by application (quarterly)

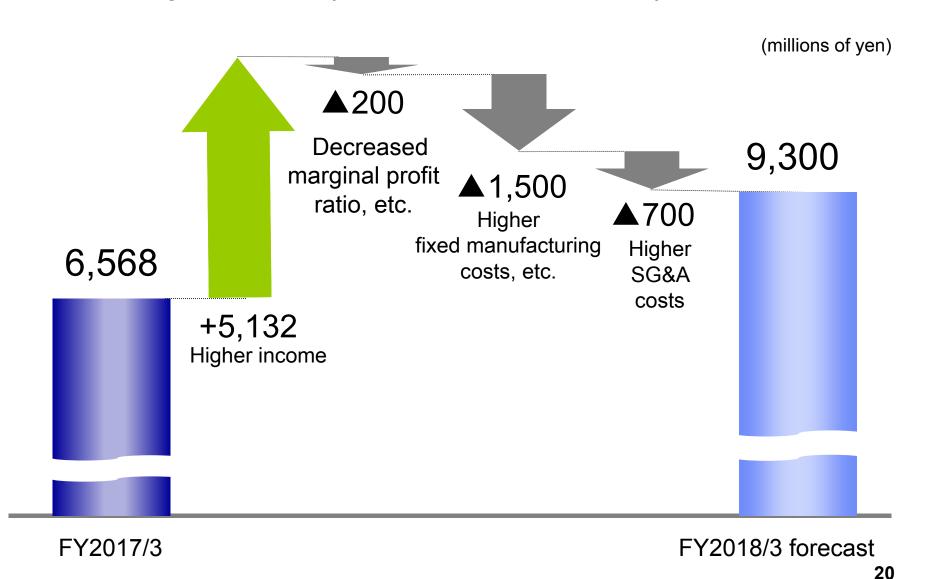

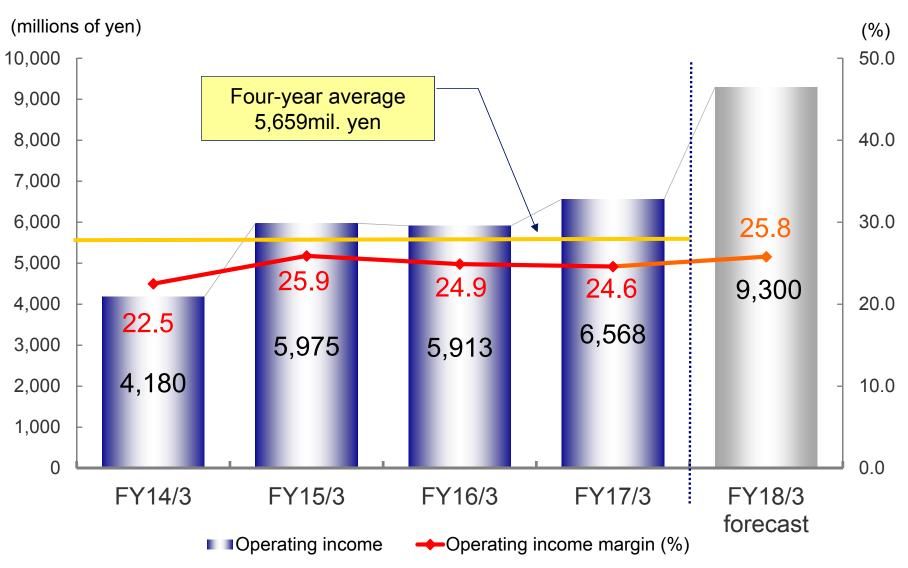
Non-consolidated Sales by application (by half-year)

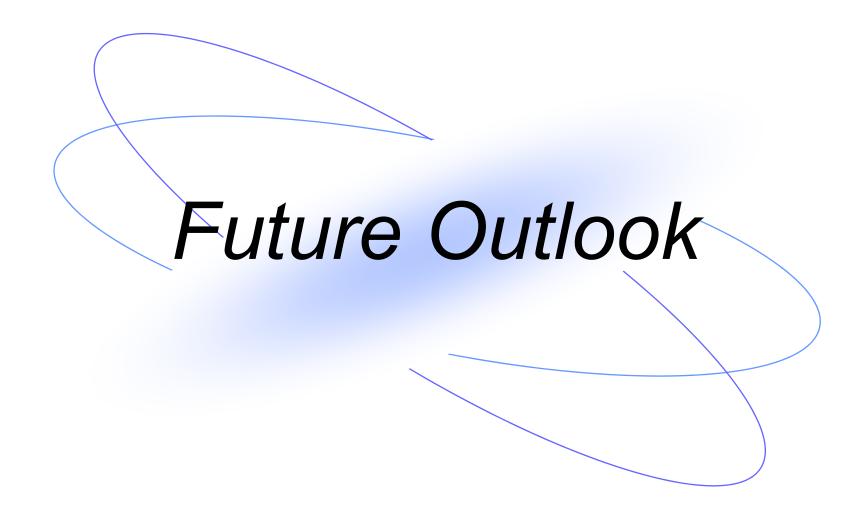


Factors in year-on-year change in non-consolidated operating income (FY 2018/3 forecast)



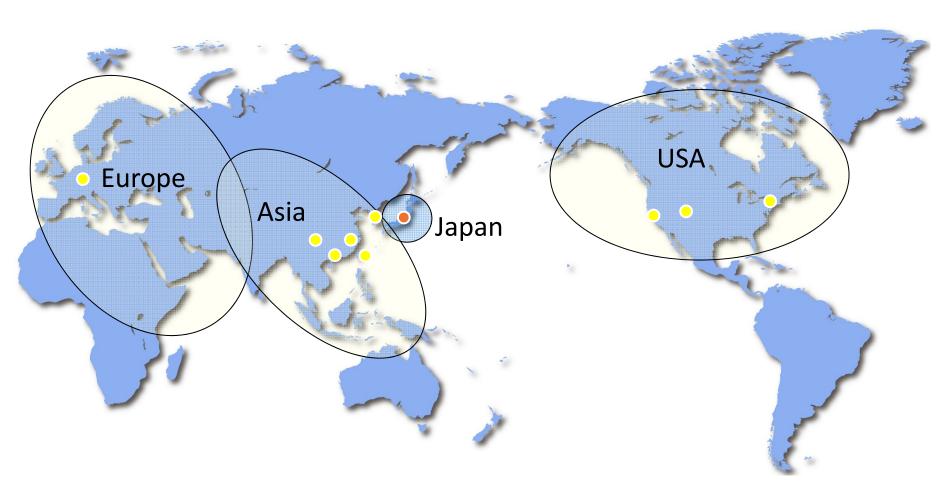
Trends in operating income (non-consolidated)



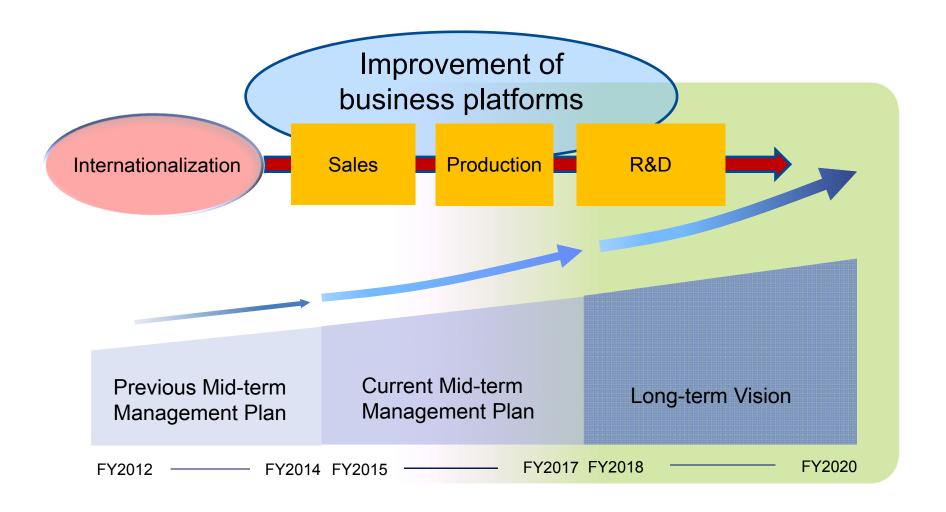

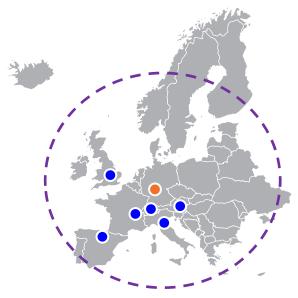

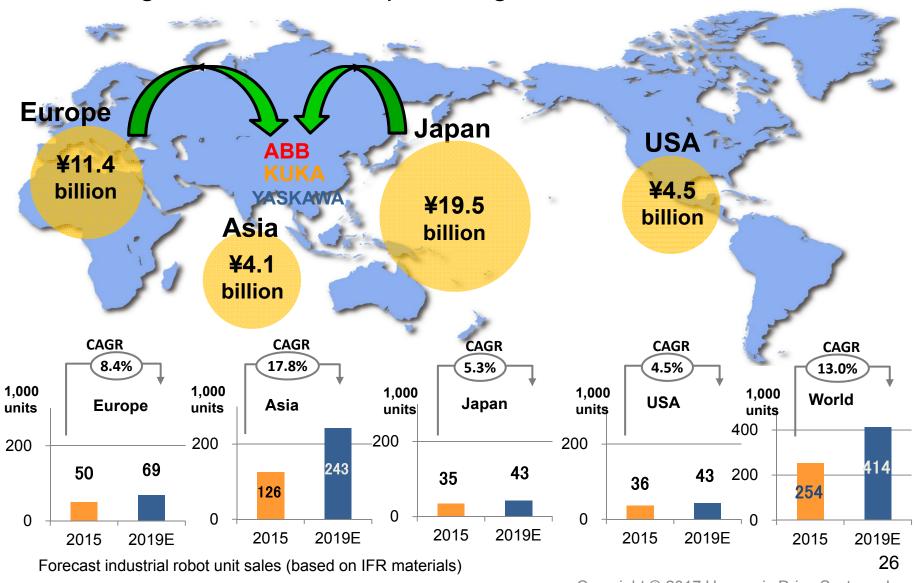

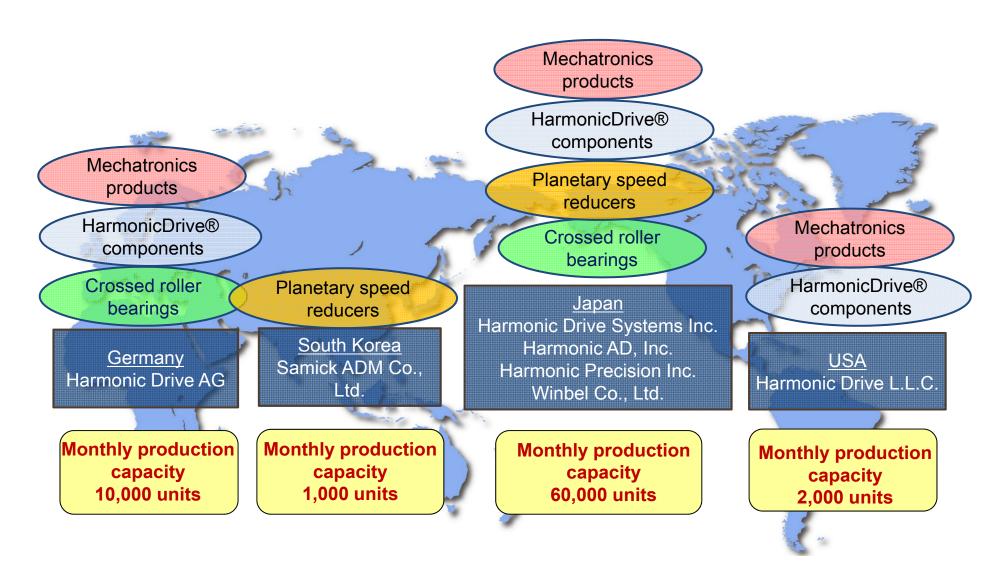

2.1 Sales Structure (FY2016 Sales)

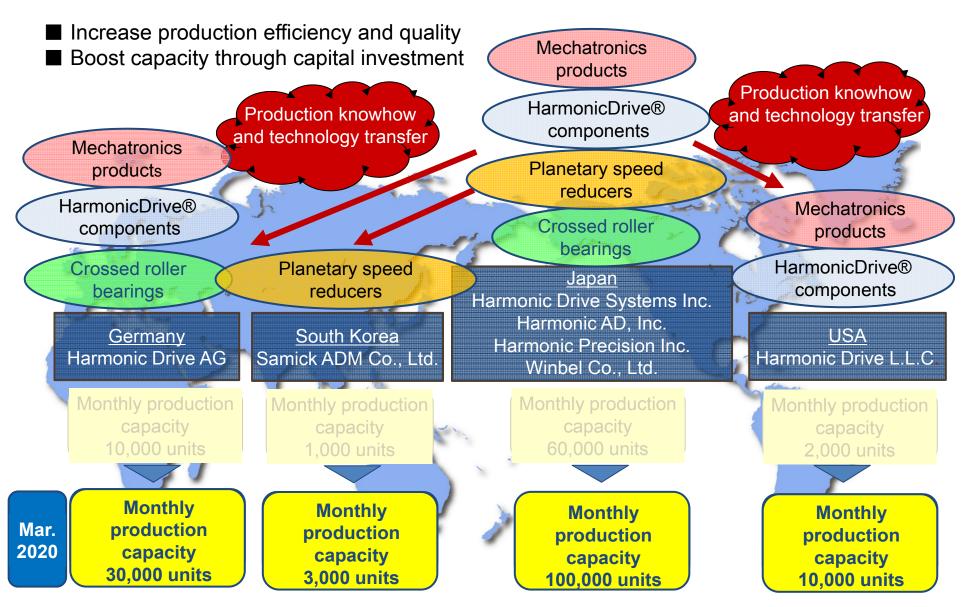

2.2.1 Production Structure (Current)

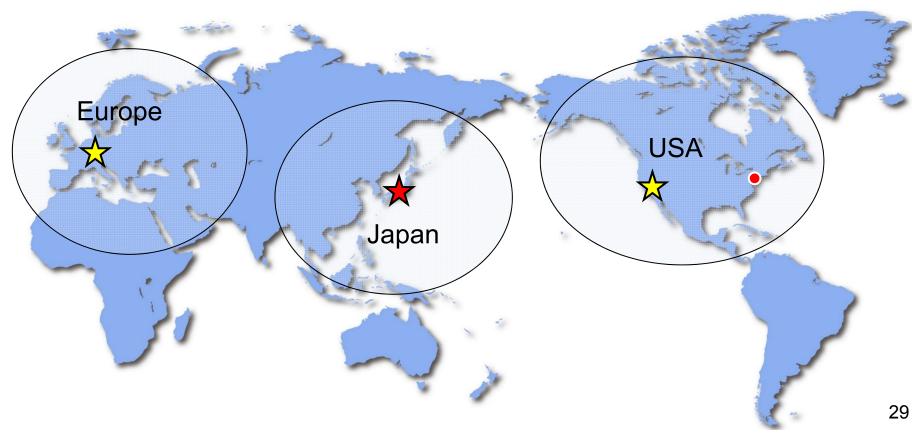

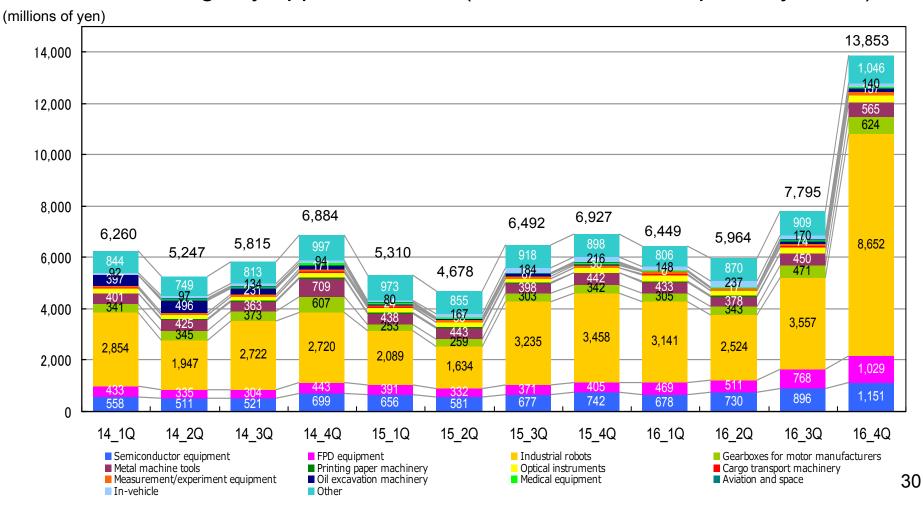

- Increasing production since March 2017 (50,000→66,000 units per month)

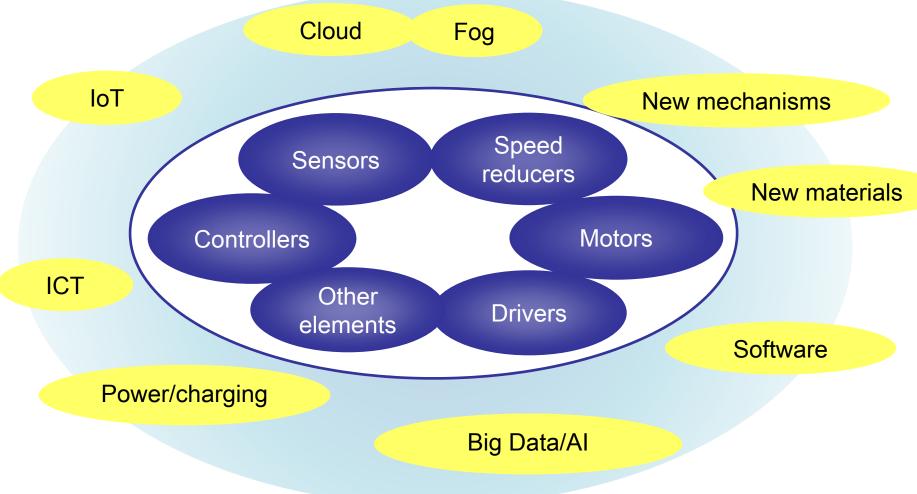

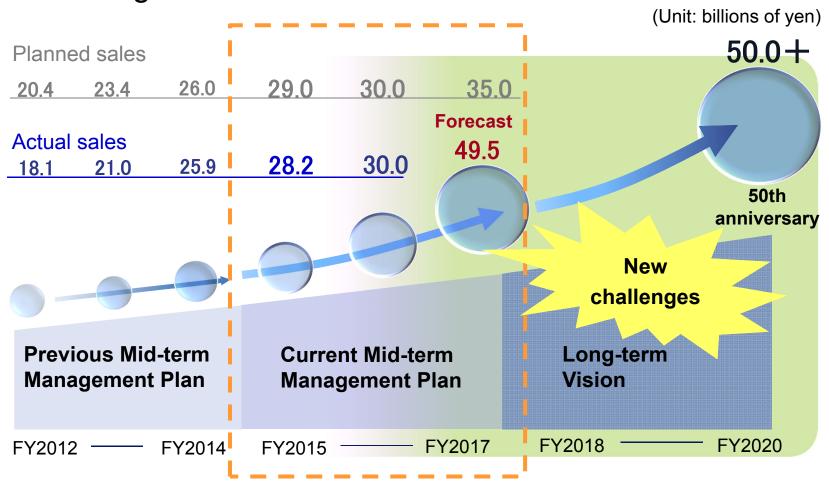
